<b>B.4b</b>	<b>A description of any known trends affecting the Issuer and the industries in which it</b>	BNG Bank's business and results of operations are affected by local and global economic conditions, perceptions of those conditions and future economic prospects. More than five years after the beginning of the global economic and financial crisis, the world economy is showing signs of recovery in 2014, but downward revisions to growth forecasts in some economies highlight continued fragilities and downside risks. Risks to growth



	<p><b>operates:</b></p>	<p>and stability stem mainly from continued imbalances – among and within countries – and from uncertainty about how economies will respond as the extraordinary monetary policy measures, including the quantitative easing programs, implemented during the global financial and economic crisis are unwound.
